VENDOR CONTRACT
GENERAL INFORMATION

- All vendors must check in with the Vendor Coordinator before occupying their vending space.
- Vendors must complete & pay for General Meet Registration to attend any meet function.
- Registrations will be accepted beginning January 1, 2020.
- **Deadline for registration is June 30, 2020.**
- \$15.00 Cancellation fee will be incurred for canceled registrations prior to July 1, 2020. No refunds for cancellations after July 1, 2020.
- Spaces are filled in a first-come first -served basis.
- Full payment required with completed contract.
- Confirmation will be sent by email when possible.
- Spaces are numbered; vendors will occupy their assigned numbered space(s).
- No changes to layout spaces without permission of the SDC Vendor Coordinator.
- No reimbursements for unused or abandoned spaces.
- No early set-up or tear-down unless requested in writing and written permission from Vendor coordinator.
- Indoor & outdoor vendors will follow same set-up, tear-down, & open hours.
- No entry to vendor area from 5:00PM until 8:00AM (exc. Tues, Aug 4).
- All vendors are expected to keep their area clean at all times.
- The host zone may refuse vendors for the following, but not limited to, these reasons:

No smoking, no firearms, no fireworks, no ammunition, and no sale of food or beverages. No illegal items, no indoor generators, no gasoline or diesel engines, pets must be on a 5 foot leash.
- Any violation of rules may cause dismissal from this event and possibly other SDC events.

- Camper &/or Motor Homes must be parked in the campground area during the meet. Parts trailers must be parked in the designated area.
